

Mental and Behavioral Health Education and **Training Grants**



Alert to CSWE Accredited Programs \$10 Million for New Training Program Expected Soon

March 14, 2012

I am writing to alert CSWE members to a new source of federal grant funding, expected to be announced very soon, that will help in your efforts to expand capacity. It is our hope that you will use this information to begin your preparations for writing a grant proposal when the announcement is issued by the Health Resources and Services Administration (HRSA) in early April. Once announced, the program's submission window is likely to be very compressed—perhaps only 30 to 45 days.

HRSA plans to use approximately \$10 million in already appropriated fiscal year 2012 funds to initiate a new program authorized in Sec. 756 of the recent healthcare reform

The funding announcement is currently being drafted in the agency, but we expect it to be called the Mental and Behavioral Health Education and Training Grant program. Its aim is to help close the gap in access to mental and behavioral health care services by increasing the number of adequately prepared mental and behavioral health providers. including social workers. All grants will be peer-reviewed and awarded before the end of the current fiscal year, September 30, 2012. Review scoring will be used as the basis of the current fiscal year, September 30, 2012. Review scoring will be used as the basis for rankings and funding decisions by HRSA staff. HRSA currently plans to devote at least another \$5 million to the new program next year. In addition to social work, psychology programs will also be eligible. It is not clear whether the grants will be


The focus of this effort will likely be on expanding training in accredited social work programs. Although the final HRSA program may be slightly different from what is described in the law, the following language from Sec. 756 is offered as a guide to your initial thinking about this opportunity:

(1) In selecting the grant recipients in social work under subsection (a)(1), the Secretary shall give priority to applicants

- Authorized in ACA, funding appropriated in FY 2012
- HRSA FOA expected in next few weeks
- \$10 million to spend before Sept. 30
- Only program targeting social work (psychology also included)
- Priority to underserved populations rural/urban, veterans, children, etc.
- BSW and MSW may be eligible
- Award size likely \$250,000-\$350,000
- Quick submission turnaround 30-45 days Lewis-Burke

VA Health Professional Scholarship Program




- Authorized in 2010 Veterans Omnibus Health bill
- Tuition assistance, monthly stipend, and other education costs (up to \$35,000/yr) for each year of a graduate/training program leading to a career in a VA facilities
- Minimum 2 year service pay back with VHA in a permanent, full-time position.
- Regulatory process to be completed in 2012



- President Obama vocal about college costs popular election-year issue.
- Student debt load becoming front-page issue, along with scheduled interest rate increase from 3.4% to 6.8%.
- Pressure on universities to demonstrate value, ensure students graduate on time, and enhance transparency.
- Bipartisan commitment to maintain Pell grant maximum award, but a shortfall looming in 2014.



HEA Implementation



- Implementation of regulations on gainful employment and program integrity per the 2008 HEA reauthorization
 - Federal definition of a credit hour
 - State authorization for distance education program For-profits sued ED, judge put a hold on the implementation.
- NACIQI
 - Charged with advising ED on accreditation issues for 2013 reauthorization
 - NACIQI finalizing recommendations:
 - Linking accreditation and Title IV eligibility
 - Coordinating fed, state, and accrediting agency authority
 - Collecting and using data
- Federal discussions do not yet impact professional accrediting organizations or CHEA, but we're watching!
