...We have been thinking about you guys through all the distress. I feel heartened by the continued discussion on NPR (and other rational news media) of Baltimore and what led to the problems there and what can be done. And also heartened to know that there are thoughtful and committed people like you there helping to do what can be done!

In terms of setting up such teams, I want to connect you to Jim Huegerich, who was the social worker who started the Crisis Unit in Chapel Hill (about 1975). It has been the model for the rest of the cities in the U.S. who adopted it. He is not just our "local" expert, but is considered one nationally. After 37 years in the crisis business I started an ombuds office three years ago for the Town of Chapel Hill. At the Burbank PD, our intern assisted their Mental Health Evaluation Team (MHET) implement the program as well as document and evaluate its effectiveness. At the Gardena PD,

- Yes. They are doing this in Houston and in Madison. When the police get a call involving a person with mental illness, the social work accompanies. BJA is also funding a big pilot project in 6 places to determine the effectiveness.
- Brookfield PD has used a social worker as well. The police chief is one of our grads---Dan Tushus.

Brookfield and Madison = Wisconsin. I assume Houston is the Texas one..... (we don't have a Houston in Wisconsin that I know of!) And BJA appears to be Bureau of Justice Assistance.
